HIGHLIGHTS

System/CorHealth Updates

- Meetings with Ontario Health and Chris Simpson are resuming as this team will
 create a document that provides guiding principles for providing health care while
 managing the ebbs and flows of COVID-19. Anticipated release end of
 August/September 2020.
- CorHealth and Clinical and Forums chairs will be submitting an article to Healthcare
 Quarterly describing the provincial approach to managing COVID-19 for the cardiac,
 stroke and vascular clinical domains, including information about the Provincial
 Forums. Conversations with the CEO and editor-in-chief of Longwoods, the journal's
 publisher, indicate the enthusiasm and support for publishing this information in the
 Fall 2020 (target October 2020 issue)



Virtual Care and Cardiovascular Rehabilitation

- CR Program activity updates were shared by three CR program sites from across the province:
 - Leslie-Anne McDonald and Julie Lessard from Seaway Valley Community
 Health Centre shared an update that highlighted the changes in their
 program since March and how they are transitioning back to in-person visits.
 Two resources noted that have been guiding their triage back to in-person
 visit were described including the Saskatoon Risk Stratification tool as well as
 the Return to Program Triage Tool. Both of these were shared with meeting
 participants.
 - Jason Petro from Hotel-Dieu Grace Healthcare shared current program offerings of in-person and virtual services. Participants were able to see some of the physical distancing measures and other measures implemented to screening, exercise spaces, and waiting rooms to ensure a safe environment.
 - Nicole Sandison from University Health Network shared highlights from UHN's planning for onsite care including a new hybrid program model of care and IPAC checklists and environmental measures in place to ensure safe inperson visits. She noted that there the hybrid model as well as a virtual only will be offered moving forward in order to adapt to a COVID-19 resurgence if needed.
- Participants engaged in a discussion regarding innovations in virtual CR delivery and hybrid models including:
 - o Patient willingness to come on-site (maintaining virtual only options)
 - o Frequency and duration of on-site visits
 - Flexibility and personalization of programs for patients
 - Weekend program offerings and issues/ challenges with hospital funding constraints due to COVID-19 deficits
 - Home exercise resources and strategies for providing patients with equipment (e.g. mailing out resistance bands)
