




# **COVID Epidemiology: Ontario**



## CardiOttawa Length of Stay Score

Dr. Louise Sun/Dr. Marc Ruel

- Decision to treat cardiac patients requires balancing the risk of delay against the risk of nosocomial COVID-19 exposure, along with competition for scarce hospital resources
- Developed and validated clinical models to predict the likelihood of low and high CSICU resource use as defined by short (≤ 2 days) and prolonged (≥ 7 days) LOS
- Derived using data from the University of Ottawa Heart Institute (UOHI)



## CardiOttawa Length of Stay Score

Dr. Louise Sun/Dr. Marc Ruel

- Validated concurrently using pan-Ontario data, as well as prospectively at the UOHI
- The CardiOttawa LOS Score was shown to be 92.1% accurate in beta testing
- A web-based app is also available to bring these models to the bedside.

#### • Context:


- Virtual care may be the new normal during the course COVID-19, as well as after


